CLIENT/PRACTITIONER AGREEMENT

I understand that Homeopathy falls under the category of Complementary Alternative Medicine and that a Homeopath is not a licensed medical physician. I also understand that any life-threatening situation should be addressed at an emergency hospital facility and not directed to a Homeopath. All information I share with a Homeopath is confidential except where disclosure is required by law or a person's life is threatened or said person is threatening the life of another. If the client is a child or pet, I am signing this on her/his behalf and take full responsibility for the information in this agreement and in the consultation.

NEW PATIENTS

New patient appointments are two hours in duration, 1.5 hours for children and pets typically. This is a very intensive consultation covering information that involves your mental, emotional, physical, and spiritual state. Homeopathy treats the whole person, not just symptoms, so detailed pieces of information is valuable and necessary to promote and provide healing.

FOLLOW-UP APPOINTMENTS

Follow-up appointments are important to assess the progress of your treatment. The first follow-up is scheduled typically 4-6 weeks after your initial consultation. Follow-up appointments for pets will vary in scheduling, depending on symptoms and conditions addressed. Additional follow-ups will be determined based on the effects of treatment. Follow-up appointments are 30 minutes in duration. These can be done in a more informal setting, over the phone, or video conference.

FEES

Initial Consultation (2 hours in duration): \$275 and includes the cost of the initial remedy, along with any phone calls or emails during the initial first month.

Pet initial consultation (1.5 hours in duration): \$75 and includes the cost of the initial remedy.

Follow-up Visits/Calls (30 minutes in duration): \$85, includes any necessary remedy (if shipping is required, there is a postage fee expense)

Acute Situation Phone Consultations (30 minutes in duration): \$85, includes any necessary remedy (if shipping is required, there is a postage fee expense) This would be for common colds, flu, or related types of symptoms. (For existing patients only; new patients would need to contact the Homeopath to determine eligibility.)

Family Rates are available: please contact the Homeopath for details.

Payment is due at the time of appointment in the form of check or cash. I am not currently accepting credit card payment or insurance. Mailed remedies will be charged the shipping rate through the United States Postal Service.

ACUTE SITUATIONS: COLDS, FLUS, INJURIES

Most non-life threatening situations can be treated homeopathically. An office visit is preferred to a phone consultation; however, if that is not possible, phone consults can be done in special circumstances. Remedies can be picked up in these situations, if available, and will be charged accordingly. I will also drop remedies off to clients that are physically or mentally unable to drive, if located within a 20 mile radius of Highlands Ranch. A fee will incur for this service.

HOURS FOR APPOINTMENTS

Although there is flexibility in my schedule, typical appointment times are Monday through Friday between the hours of 7:30 am until 6:00 pm MST. All scheduled appointments must proceed on time as to respect your time and mine; as well as the next client's. The full two hours is needed to take a complete case. It is very important that appointments start and end on time. Please arrive on time for your appointment at the designated location discussed with the Homeopath.

CANCELLATION POLICY

Twenty-four hours notice to cancel appointments without charge is required. Appointments not cancelled within that 24 hour window will be charged the full amount of the visit scheduled.

CONFIDENTIALITY

All Homeopathic consultations are completely confidential. If you would like me to communicate with another healthcare provider or person, you must complete a written, signed release form. Only under the condition that one's life is in danger or there is danger to harm another person will confidentiality be compromised.

INSURANCE

Insurance is not accepted at Homeopathic Healing Colorado at this time. All fees are your responsibility and payment in the form of cash or check is required. Venmo is also a payment option available.
